ISO 50001:2011 specifies the requirements for an organisation to establish, implement, maintain and improve energy management systems (EnMS). ISO 50001 is a voluntary standard that applies to all aspects of an organisation's energy use.

By establishing the systems and processes necessary to improve energy performance, including energy efficiency, use, consumption and intensity, you can reduce your energy costs, GHG emissions and other environmental impacts. SGS certification enables you to take a systematic approach to continual improvement of energy performance and emission control, and shows your commitment to effective energy and environmental management systems.

Improved energy performance provides rapid benefits for an organisation by maximising the use of energy sources and energy related assets at the same time as reducing both energy costs and consumption.

HOW THE CERTIFICATION PROCESS WORKS

- Step A - Tailored proposal from SGS.
- Step B – Optional 'pre-audit' of readiness and weaknesses.
- Step C – Formal audit 'Stage 1 – Readiness Review'. Documents and other key system elements are evaluated and non-compliances reported.
- Step D – 'Stage 2': interviews, examination of records and observation of working practices. Non-conformances are addressed.
- Step E – Surveillance visits to check the system and action plan implementation.
- Step F – Re-certification audit after three years.
